LEAGUE MATCH DATES: MARCH 26, APRIL 30, MAY 21, JUNE 11, JULY 9, AUGUST 5, SEPTEMBER 10, OCTOBER 15

ELIGIBILITY: OPEN TO THE PUBLIC. COMPETITORS NEED NOT BE NRA OR PECONIC MEMBERS.

SQUADDING: ON THE RANGE AT 07:00 TO 07:45. FIRING STARTS AT 08:00.

FEES: INDIVIDUAL MATCH FEE IS \$20.00. JUNIORS AND U.S. ARMED FORCES \$15.00. ONE TIME NRA LEAGUE REGISTRATION (OPTIONAL) \$10.00. CHALLENGE FEE \$2.00.

COURSE OF FIRE: 200 YARD NRA REGIONAL MATCH COURSE. MATCHES MAY BE ORGANIZED INTO 2 OR 3 RELAYS. ALL COMPETITORS ARE REQUIRED TO PERFORM PIT DUTY AND PULL TARGETS. ENTRIES ARE LIMITED TO THE FIRST 66 PAID SHOOTERS.

RULES: CURRENT NRA RULES FOR APPROVED MATCHES APPLY. NON NRA MEMBERS SHOOT AS MASTER UNCLASSIFIED (MU).

RIFLES & EQUIPMENT FOR LOAN: AR15 A2 RIFLES ARE AVAILABLE FOR LOAN AT NO CHARGE. COMPETITORS BORROWING RIFLES MUST CALL OR E-MAIL P.O.C. PRIOR TO THE MATCH AND ARE REQUIRED TO PROVIDE THEIR OWN GOOD QUALITY FACTORY AMMO. HAND LOADS ARE NOT PERMITTED IN LOANER RIFLES. LIMITED AMOUNT OF SPOTTING SCOPES, MATS, JACKETS AND GLOVES ARE ALSO AVAILABLE FOR LOAN.

AWARDS: APPROXIMATELY 50% OF THE ENTRY FEES AFTER EXPENSES, WILL BE RETURNED TO COMPETITORS AS CASH AWARDS. NRA LEAGUE MEMBERS ARE AWARDED PLAQUES FOR CLASS WINNERS AT THE END OF THE YEAR.

REFRESHMENTS: WATER IS AVAILABLE. COMPETITORS ARE ADVISED TO BRING LUNCH.

DIRECTIONS: LIE TO EXIT 69 NORTH (WADING RIVER ROAD) ABOUT 6 MILES TO GRUMMAN BLVD. TURN RIGHT ON GRUMMAN BLVD. ABOUT 2.5 MILES TO PRSC FRONT GATE (PAST SWAN LAKE GOLF COURSE) 389 RIVER ROAD TURN RIGHT INTO CLUB AND FOLLOW SIGNS TO RIFLE RANGE. **DRIVE SLOW** NARROW BUMPY DIRT ROAD WITH BLIND CURVES.
